- 1. The Applicant organisation meets the following eligibility requirements for the ACF Cyprus programme:
 - the Applicant is a (underline applicable option) public, private entity, nongovernmental entity;
 - shareholders of the Applicant organisation are not consortium members of the Fund Operator.
- 2. The Applicant organisation is not in a situation which would prevent it from taking part in the ACF programme in the Republic of Cyprus and accordingly:

 - has met its obligations relating to the payment of social security contributions or taxes under the legislation of the Republic of Cyprus;
 - has not been the subject of a judgment which has the force of res judicata for fraud, corruption, involvement in a criminal organisation or any other illegal activity;
 - has not been declared to be in serious breach of contract for failure to comply with its contractual obligations subsequent to grant award procedure financed by the EEA and Norway financial mechanisms, EU structural funds, or state aid.
- 3. The Applicant organisation follows the principles of common values of respect for human dignity, freedom, democracy, equality, the rule of law and the respect for human rights including the rights of persons belonging to minorities.





- 4. I am unaware of any other circumstances provided for in this document which may prevent full implementation of the project, or cause any delays in the implementation process, or that the project could not be completed until the final term of its implementation.
- 5. The Applicant organisation did not violate principles of sustainability, gender equality, and non-discrimination established in the EU by approaching the Active Citizens Fund.
